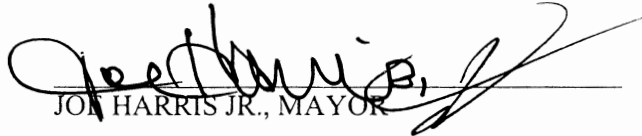

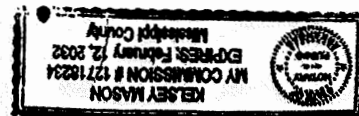

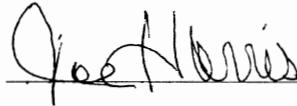
Roll was call and all Council members were in favor.
